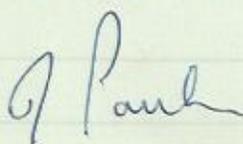


Meeting of Broughton Parish Committee at 4,
Flowery Bank on Monday, Feb. 4th. 1985.

Present: - Chairman, Vice-Chairman, Treasurer & Clerk.

1. Minutes from the previous meeting were read, approved & signed by the Chairman.
2. It was agreed as in previous years to allow Miss B. Ward a "rent-free month" ~~£~~ in appreciation of her work in keeping the bus shelter tidy throughout the year.
3. The question of placing name signs in different parts of the village was discussed as confusion often arises with delivery- vans. It was decided that the village would benefit from signs placed at "Manor Park", "Beech Crescent" and "Flowery Bank" these being the areas that ~~were~~ led to confusion.
4. The Tree-planting Scheme was once more discussed. In early November 1984, The Chairman & Treasurer met Mr. Clayton and discussed possible locations with him. As no money was at present available it was decided that Mr. Clayton would contact the Parish Meeting on this matter at a later date.
5. Correspondence recently received was read. The letter re- Civil Defence was discussed and Mr. J. Paulin agreed to attend the Ryedale Course of Meeting in Malton.
6. A litter-bin was requested for Manor Park. Repairs were needed to the Bus Shelter which the Committee undertook to do.

 4. The Clerk reported that an application had been made for a Precept of £440 for the street-light in Maron Park.
 5. Under the Tree Planting Amenity Scheme, Broughton has had trees planted in Broughton Green Lane, and Broughton Lane by Ryedale District Council.
 6. As from April 1st 1986, Maron Park Estate is in Broughton Parish and not Swinton Parish due to the Boundaries Review.
 7. A seat is to be repaired and placed at the corner of Beadycroft Lane.
 8. The plans submitted by Mr. G. Sedman for an extension to Boswell House, Broughton received from Ryedale District Council were reviewed, & no objections were raised.
 10. No other business, so the Chairman declared the Meeting closed.
 9. It was agreed to allow Miss B. Ward one month's rent free in lieu of her clearing out the bus shelter.

1. The minutes of the last meeting were read, approved & signed by the Chairman.

Matters to discuss:-

1. The Precept:- Owing to the upkeep of the street light in Manor Park Estate, & with estimates from the N.E.E.B. the sum of £40.00 was agreed as a levy on the rates. The Chairman signed the Precept form to be sent to Ryedale District Council.
2. Bulb Planting in the Village: In August a letter was received from Mrs. Elaine Hall of the Keep Britain Tidy Campaign re planting of bulbs, shrubs, etc on the public roadsides in the village. We replied to Mrs. Hall that we were interested in her project and a meeting was arranged with Mr. John & Mrs. M. Paulin a walk around the village & discussion re flower-beds & shrubs etc. to be placed. Mrs. Hall agreed to contact R.D.C. re-plans etc. & to contact the Headmaster of Amotherby School to ask his permission for some of his pupils to help in the project. The representatives of the N.R.^{CC} who visited the sites of the proposed planting agreed to bulbs & trees only to be planted. Mrs. Hall & Mr. John also undertook to arrange for a Volunteer Group to visit the village, and repair the bus shelter and park and fix a seat at the corner of Beedycroft Lane. They also were to dig the holes prior to the school-children planting daffodil bulbs.

On Sept 30th the Clerk & Mrs Hall visited Castle Howard Garden Centre and purchased 2 sacks of daffodil bulbs & 80 crocus bulbs from Parish Funds.

On Oct 7th the Volunteer K.B.T. Helpers came to

the Village and repaired & painted the bus shelter, the materials being provided by the Parish Meeting from Parish Funds. They also sited the Garden Seat & prepared the ground for the planting of bulbs.

Oct 8th: The Children from Amotherby C.P. School with a member of Staff & Helpers to help to supervise care & planted the bulbs.

Letters of appreciation were sent to Mrs. Hall & the K.B.T. Helpers & to the Headmaster & children of Amotherby School.

2. Plans for an extension at "Quarry Bank" for Mr. & Mrs. A. J. North.

A letter & plans have been received from Ryedale District Council for our observations. The Meeting discussed the plans & it was pointed out that there was only a space of 6" at one point between the proposed extension & the next property & only 18" at the widest point. It was felt this was not adequate if any repair work was ever needed to either property in the future. These points were stated in a reply to R.D.C.

To Discuss: The future of "White Cottage".

On Monday April 6th, Mrs. B. Kund reported that the front wall of the adjacent cottage had partly collapsed.

The inspection by Mr. J. Faulk, Mr. R. Kund, Mr. S. Saut was made, & in their opinion this was a danger hazard that needed urgent repair. It was decided to ask the advice of Ryedale District Council. On Thursday April 16th, Mr. Chapman from R.D.C., Mr. Faulk went to inspect the damage. Suggestions made by Mr. Chapman were 1) to shore up the end of Miss. Wards cottage with timber, & to use concrete blocks at the front to hold up the roof.

2) to demolish the damaged cottage and re-erect the

choosing wall between the two cottages.

3) to find alternative accommodation for Miss

Ward & demolish both cottages.

After much discussion it was decided to

ask Miss Wards for an estimate for making

Miss Wards cottage safe - demolishing the damaged

adjoining cottage. Concern was expressed for Miss Ward's safety & health, and the committee felt that the matter was one of emergency.

Lighting: - A letter had been received from R.D.C. concerning Footway Lighting Improvements. This was discussed, & it was agreed that the village would benefit from 3 new lights but our financial situation was not adequate to provide them.

Letters: - A letter re "Rye Dale Litter Campaign" was discussed & it was agreed that we had no great problems regarding litter in the village.

No other matters to hand, the Chairman closed the meeting.
