The Treasurer's Report: - Current Account. £86.72p.

High Interest Account (Dec. 29th 1989) £23,834.04p.

1. The Bus Shelter: This has become covered with Ivy on one side which requires removal. The Chairman & Treasurer agreed to undertake this task. A vote of thanks was given to the Chairman for the job of cleaning the bus shelter regularly.
2. The Steps on Flowery Bank leading to the main road are now in a dangerous condition. A letter is to be sent to the Highways Dept. requesting repair work and the possibility of a hand-rail.
3. It was decided to purchase further bulbs for the grass verges in the village, & to ask help from the Children of Amotherby School in the planting of them.
4. Concern was expressed regarding the flooding of the Main Road between Ashdale and the Bus Shelter after 1 hrs. rain fell. It was felt the drains were unable to cope.

3. A letter was received from the Sec. Secretary of the Amotherby & District Pensioners Committee requesting a donation to their Summer Outing. It was decided to send a donation of £60.
4. The Treasurer reported a balance of £86.72 in the Current Account, and £24588.68p in the High Interest Account at the Year End.

PRESENT. The Committee and 16 Residents of Broughton

1. The Chairman opened the Meeting and introduced the Committee.
2. He explained the purpose of the Meeting: - to discuss the finances of the Parish, and the request from Swinton & District Playing Fields Association for financial help.

After discussion, a vote was taken and the following decided, unanimously: -

To give a donation of £3,000. Prop Mr. B. Watson.

Sec. Mr. S. Saul.

To guarantee a loan of £10,000. interest free for 5 years if needed, and hereafter at an interest rate to be decided by both parties. Prop Mr. B. Watson.

Sec. Mr. J. Lund.

3. Other Business: Street Lighting: It was decided that the village needed street lighting, and 10 new units were suggested, and the one present light in Manor Park needed attention.
4. Road Signs: It was decided that street signs for Manor Park and Beech Crescent were needed. It was also suggested that a sign be erected asking motorists to drive carefully down the village as children were often in danger of speeding vehicles.
5. It was agreed to give a donation of £80 to the Committee of Swinton Reading Room to help towards the improvements needed to comply with Fire Precautions Regulations.
6. Spring Bulbs to be purchased for the grass verges in the village to add to the present ones.
