Broughton Enclosure Award

Date: 4 September 1789

Land to be enclosed: a large open field situated in the township of Broughton, in the parish of Appleton le Street

Overall acreage: 325 acres, 3 roods and 19 perches

Roads to be established:

- A common public road or King's Highway, of the breadth of 40ft, leading from the north-east corner of the field which was to be divided, towards the town or village of Broughton to where it adjoins a road leading to Broughton. To be called the Malton Road.
- 2. A common public road or King's Highway, of the breadth of 40ft, leading from the south-west part of the open field belonging to the Borough of New Malton, extending westward towards Conseysthorpe to where it adjoins a public road in the township of Swinton. To be called the Bragate Road
- 3. A private road or way of the breadth of thirty feet to be used by the inhabitants of the Township of Broughton leading from the Malton Road to the Bragate Road. To be called the Broughton Private Road. Gates to be maintained at the joint expense of all the proprietors of the field to whom allotments are made.
- 4. Private Road or way of the breadth of twenty feet for the use of Thomas Medd and Reverend Mr Ward leading from the Broughton Private Road over and across the north end of the allotment of nine acres, one rood and twentyfour perches awarded to Charles Yarborough, to the lands hereby awarded to Thomas Medd and to the old inclosure of John Ward.

- 5. A private road or way of the breadth of twenty feet for the use of the owners or occupiers of the Glebe Land leading from Broughton Private Road, across the allotment awarded to Thomas Medd to where it adjoins the Glebe flatts belonging to Thomas Medd. To be called the Middle-Cave-West Road.
- 6. A private road or way of the breadth of twenty feet for the use of John Ward, his tenants and servants leading from Broughton Private Road eastward through an allotment made to Ralph Robinson, towards an allotment made to John Ward. To be called the Middle Cave East Private Road.
- 7. A private road or way of the breadth of twenty feet for the use of the owners and occupiers of the Glebe Land leading from Broughton Private Road, westward through the north end of the allotment of 21 acres and 26 perches awarded to Charles Yarlborough esquire, to the Glebe Flatts belonging to Stephen Croft esquire.
- 8. A private road or way of the breadth of twenty feet for the use of John Hutchinson, leading from Broughton Private Road westward through the allotment of 7 acres, 2 roods and 33 perches awarded to Mrs Parkinson, to the allotment made to John Hutchinson.
