22.3 Parish Issues

- **Street Lights**

It was agreed to replace the remaining non led lamp post when it fails in due course. It had been repeatedly reported that the lamp in Manor Park be repaired as it is constantly on. We were told in November that a replacement pole was required but are still waiting for the work to be done. It was also noted that we are not paying extra for wasted energy.

- **Highways & Pot Holes**

Clerk to request that the white lines at the Manor Park junction be repainted. Although it is highways issue, it was also noted that Manor Park residents are concerned about parking (of vans in particular) on the Manor Park junction. It makes it difficult to see whether traffic is approaching from the North of the village.

- **20s Plenty Campaign**
